**Admission & Placement:** Once a child turns 24 months old they can be admitted into this program, regardless of the time of year. However, in order to be placed in our 3 & 4 year old Pre-K program, they must meet the age requirement of turning 3 years old by October 1<sup>st</sup> and the child must be fully potty trained. Once these conditions are met, they may then transition out of the 24 mo. - 3 year old program into the 3 & 4 year old Pre-K program for the next school year.

Please note, regardless of when the child enters the Pre-K program, they still must meet Kindergarten age requirement of 5 years old by October 1st in order to be enrolled in Kindergarten.

**FACTS Tuition Management Program:** Calvary Academy utilizes the FACTS Tuition Management Program. FACTS Tuition offers a simplified approach to tuition collection. All families, except those that will make a full payment in advance, will participate in the FACTS tuition program. If enrolled in FACTS during 2017/18, you are automatically enrolled for 2018/19. There is **an annual FACTS enrollment fee** (assessed by the FACTS corporation) which will be **automatically deducted 14 days after you receive your confirmation letter from FACTS**, or will be included on your first statement from FACTS. Please note, FACTS charges a credit card fee if payments are made by credit card.

### **Payment Options:**

- Ⓟ 10 month payments run from July through April.
- Ⓟ The annual payment is due on or BEFORE July 20 - a 3% discount will be applied. This option requires payment by cash or check payable to "Calvary Academy." Excludes credit card payment and FACTS enrollment is not necessary.
- Ⓟ Monthly payments are due directly to FACTS on the 1st, 5th or 20th of each month, as follows:
  - 1st = monthly statement/invoice, 5th or 20th = automatic withdrawal from a checking or savings account
- Ⓟ All tuition, fees, and after care payments that are 5 days or more after the due date are considered late, and a \$25.00 late fee will be charged.

**Delinquent Accounts:** Families with delinquent accounts cannot re-enroll until all financial obligations have been met. Tuition account must remain current through the end of the year in order to maintain enrollment status. Any accounts more than 30 days past due are subject to suspension of enrollment.

**Withdrawn Students:** Families withdrawing from Calvary Academy must do so in writing indicating last day of school attendance and are responsible for the full month's tuition corresponding to the withdrawal date. A student who withdraws or is dismissed during the school year will be charged a one-month tuition penalty. Student's records will be held until all financial responsibilities have been met.
